**MEETING WITH ATTORNEYS
and
PRIVATE INVESTIGATORS**

On July 2, 2003 (Wednesday) at approximately 0900, a prescheduled meeting regarding the investigation into the death of victim – JonBenet Ramsey, took place at the Boulder District Attorney's Office. In attendance were personnel from the Boulder DA Office along with attorneys and investigators from the private sector that had represented John and Patsy Ramsey. The purpose of the meeting was to reacquaint all personnel with the roles each respective individual performed during their involvement into the investigation of the death of JonBenet Ramsey and/or the representation of Ramsey family members. Additionally, each member from the private sector was requested to share information with representatives of the Boulder District Attorney's Office, regarding potential leads that they had uncovered or developed. This information exchange was requested in part; due to the fact the Boulder District Attorney's Office is now responsible for the investigation into the murder of JonBenet Ramsey.

DA Mary Keenan advised the persons in attendance her office would be reviewing correspondence including letters, E-mails and faxes along with Telephone tips received during the first six (6) months of the investigation. It should be noted however, this office continues to receive a large volume of correspondence and Telephone Tips on a daily basis from numerous citizens who desire to voice their theories on the person or persons responsible for the death of JonBenet Ramsey.

Additionally, Ms. Keenan said her office was investigating a lead centering on 3rd Party DNA (Male Depositor) found on the underwear of Jonbenet Ramsey, from the night of the murder.

Furthermore Attorney Bryan Morgan mentioned, "Lawyers have changed and five (5) years of files have been shipped back and forth." Mr. Morgan added he was pleased with the "Open minded attitude" displayed by the Boulder DA Office in researching that an intruder may be responsible for the death of JonBenet Ramsey.

Members of the private sector then explained his or her original role in the case investigation. The initial information that they shared has previously been documented within numerous prior supplemental reports and/or letters or memos that are contained in various case files.

The following represents a list of topics that the Attorneys or Private Investigators said they had researched and will share with the Boulder DA Office.

1. The discovery of two (2) "Barbie Dolls" found wrapped in grey duct tape on the Ramsey residential home property in May and June 1997. Per Atty Jennifer Gedde.
2. Background of witness Scott Gibbons re-finding the Barbie Dolls.
3. Background of the "Espirit News Article" on John Ramsey and other entrepreneurs. Mr. Ramsey had a heart drawn over his photo while other persons in the news article had an "X" drawn over their photos. The news article was found in the Ramsey home on a bookshelf.
4. Background of Jay Olowksi (Pasta Jay.)
5. Background of Pasta Jay's employee "Gardineer."
6. Background of Sandra Henderson-former employee of Access Graphics who was terminated after stealing funds from Access Graphics. She was charged and was sentenced to imprisonment on a conviction of Felony Theft. Ms. Henderson also lost her house, was divorced and filed for Bankruptcy. She had to pay \$100,000.00 on the Bankruptcy and still owed \$18,000.00 for a total of \$118,000.00, the same amount as appears on the Ramsey ransom note.
7. Background of Susan Stine- close Ramsey family friend.
8. Background of "Otto Vodonner" convicted of Sexual Assault on a Child and resided one (1) block from the Ramsey home in 1996.
9. Background of Burglaries and Sexual Assaults occurring in the general area of the Ramsey Home (755 16th Street) during December 1996.
10. Background of Beauty Pageants that JonBenet Ramsey competed in as well as other child beauty pageants.
11. Location, analysis results and photographs of the basement "elevator door" that had been removed from the Ramsey home when Mike Bynan was examining the residence. The door was determined to have been "Cut into thirds" for removal from the basement.
12. Background of unusual, harassing or hang up phone calls received at the Ramsey home just prior to the murder of JonBenet Ramsey on 12-26-96.
13. Background of "SBTC" license plate database reports.
14. Background of a "Blue bag" and rope adjacent to the bag. Both items were observed in CSI photos near a chair in the guest bedroom (Bedroom of John Andrew Ramsey.)
15. Long Distance phone bills from the Ramsey Charlevoix home.
16. Background of contractors and sub-contractors involved in the remodeling of the Ramsey home as well as the preparation for the "Parade of Homes."
17. Background of the examination of the knots/ligatures.
